6. **Safety Policy:**

- **Vaccinations**

Require proof of current vaccinations for rabies, Bordetella, and DHPP (distemper, hepatitis, parainfluenza, and parvovirus). Dogs should also be free of contagious diseases for at least one month before boarding.

- **Staff**

Have a low dog-to-staff ratio so that staff can give each dog more individual attention and supervision. Also, look for a daycare with compassionate, trained staff who treat animals well and don't use harsh physical or verbal reprimands.

- **Environment**

Make sure the facility is secure and free of hazards, with enough space for dogs to run and play. Regularly inspect equipment like toys and agility equipment to ensure they are in good condition.

7. **Bite Policy:**

By my signature I recognize that **(Tammie's Dog Service's & Training LLC)** has counseled me about the danger my dog may be, and that euthanasia may become the safest option for this case.
